The institute offers 3 programmes of three years Degree i.e.B.COM., B.S.C. and B.C.A. The Academic Committee of the college supervises the academic activities i.e. Framing the syllabus, preparing the academic calendar and accordingly functioning. The syllabus is framed in accordance with the affiliating university. The skill, employability and entrepreneurship in the curricula are specified in some programmes.

The college has designed some courses, arranges some programmes, conducts seminars and workshops relating to gender sensitization, environmental sustainability, human, moral and ethical values, etc. The preparation and execution of teaching plans are as per academic timetable at institute as well as at departmental level. Teaching plans made by individual teachers. The ethical and moral values and societal responsibilities are inculcated among the students through different forums like Student Union Council, Sports and Cultural forum, and NSS programs. The students' involvements in the activities are visible.

The curriculum designed by the affiliating university i.e. Mahatama Gandhi kashi Vidyapeeth with the approval of concerned BoS, the college executed the curriculum in toto. All the Departments have been implemented IT enabled student centric methods for enhancing learning experience achieve programme objectives and ensure student learning and knowledge management by employing various ICT effective classroom teaching, providing library facilities for self-learning that have helped them for the ensuring the

development.

Qualitative analysis of Criterion 3

Substantial number of the teaching staff has Doctoral Degree (Ph. D) but no one is recognised as research guide. Not a single project has been funded by Government or other any Agencies. In last five years, fifty five (55) publications were made in (UGC) refereed journals, eleven teachers have contributed in (37) books, chapters and contributed papers on a small scale in national and international conference. The College has conducted (25) Seminars/conferences/workshops during the last five years. There are industrial linkages as well as 40 functional MoUs. College doesn't have any patent to its credit in last five years. moreover, not even an attempt to file for the patent can be seen.. Institution needs to conduct Seminars on the intellectual property rights. Post graduate teachers should be motivated to enrol for research for holding Ph.D degrees. Teachers with Ph. D should be encouraged to take up research scholars and receive research grants from various funding agencies and industries. All the faculties should increase their contributions to publications and book writing. The institute has 22 collaborations/linkages for Faculty exchange, Student exchange, Internship, Field trip, On-job training, research etc during the last five years which is satisfactory.

Major extension activities are done mainly through NSS. NSS unit of the College regularly participate in different extension activities for fulfilling the demand of social responsibilities. NSS unit regularly organizes Major extension and outreach programmes conducted in and outside college include Blood Donation Camps, AIDS Awareness Programs, Swachh Bharat Abhiyaan, Clothes donation drives, Voters Awareness Camp and awareness regarding prevention of diseases. The total number of extension and outreach programs conducted in collaboration with industry, community, and Non- Government Organizations through NSS and during last five years are 41. College has received 15 awards for these activities by Government and Government recognised bodies. Contribution of the institution is remarkable in extension activities.

Sunbeam College for Women is a pioneer in Women education and it caters to the educational needs of female students hailing from adjoining towns. The college has 24 Classrooms, 2 Seminar halls, 1 Auditorium and 5 labs. All the classrooms are equipped with technology such as projectors, smart boards, wireless microphones, sound systems. Minimum electricity is consumed by classes as light and air is naturally available. The Science departments have allocated required classrooms for teaching and Science departments and separate laboratories for Chemistry, Physics, Botany, Zoology, and Computer Science, At present, 24 (Twenty four) classrooms, 5 (Five) laboratories, and 02 (two) seminar halls and one (1) Auditorium. 100 percent of classrooms and seminar halls are ICT enabled. Wi-Fi with capacity of over 300 Mbps is provided to students and teachers within the campus. College has well equipped computer lab with over 131 computers.

Sunbeam College has well library with around 10,650 books, 20 magazines, 10 journals, 5 newspapers daily are available in the library. Average annual expenditure for purchase of books / e-books and subscription during the last five year is 5.967 Lakhs.

College provides both outdoor and indoor sports facilities Table-Tennis, Chess, Carrom, a multipurpose ground Basketball, Badminton and Volleyball. The institute has well equipped gymnasium. The college students has been compititing disrtict /state/ national levelssports and games, The college is having well equipped e classrooms. The college is having two computer laboratories which are accessible to all UGand PG students. The college is having Yoga master to train the students in Yoga. The college is also having Gymniasiam, with sufficient equipment.

The development committee of the College is entrusted with supervising the process of physical and laboratory equipment maintenance. Budget allocation is made for the maintenance of Infrastructure. However the college needs to improve the intake of new and advanced books.

The College has Alumni association recently registered on 16 Dec,2020. "Alumni Association" having registration number VAR/06467/20212022. At present the association is comprised of more than 310 members. It is notable that Alumni association is invited for various activities such as Grooming sessions, career counselling, mentoring the juniors etc. It also helps in the Placements and providing of Internships to the students studying in the college. The association also contributes near about Rs 4 lakhs. The association can be more functional towards the academic and non-academic activities.

The college student council has been organizing several events to promote Nationalism among the students. The student council also involved all students to [articipate actively in the events like sports, yoga, cultural activities and othe personality development events. The college alumni association has been organizing get together with all alumni and contributing significantly for the developmental activities of the college both academically and also for facilities to the students.

The students also placed in various committees of the college like anti ragging, anti seual harssment, cultural and other extention activities, The almuni association of the college needs to be strenthened by adding students those who were placed in good organization. The committee felt very happy to note that one of the almuni of this college was first women pilot to fly Rafael.

Sunbeam College for Women is fulfilling the educational needs of female students hailing from adjoining towns. The college vision is appropriate as per the need of the society where it is situated.

The organisational structure is in placed. The Management Committee is the Principal executive body of the College and, is the apex body which is involved in framing the strategic plans and policies. It is also responsible for the operation of the college. The Management Committee appoints the Principal of the institution and is advised and supported by Management Committee. Principal investigates the curricula, teaching methods, student progress and policies and procedures, budget, hiring and evaluation of staff with the help of the senior teachers.

Administrator is responsible for all administrative functions. IQAC promotes quality parameters in the

college. It is formulated based on the recommendations given by the NAAC. The IQAC Coordinator is responsible for development, application and monitoring of quality benchmarks. Head of the Departments are responsible for the maintenance of standards of education, teaching and training, examinations and tests within the Institution, approval of syllabi, admission process, teaching learning and evaluation methodologies and research initiatives. Naturally all the committees are reporting to head of the institution. E-governance is seen in area of Administration, Finance and Accounts, Student Admission and Support and Examination.. It is stated that all the welfare measures are implemented in institute according to rules and regulations of the State Government. The Institute permits the faculties to participate in seminars, workshops, and training programs nationally. Faculties participating in these courses can avail the Career Advancement Scheme as per the UGC norms. Motivation is needed to increase the participation of faculties in seminars, workshops and FDPs.

The Audit team in general assessed the financial performance of the institution by minutely reviewing the accounts of the college to ensure the validity and legality of financial records. The internal audit is conducted by Jain Bothra & Company, Chartered Accountants. External financial audit is taken by M/s S. Aahuja & Company, Chartered Accountants annually. The college has Internal Quality Assurance Cell. IQAC conducts seminars, workshops, expert lectures. IQAC initiated several quality improvement activities in the college. The primary aim of IQAC is to identify and institutionalize best practices in the college. e.g., Feedback System, Blended learning.
